I do further, on behalf of myself and my crew with their full permission, agree and do hereby indemnify the aforesaid organizations and any persons from claim, demand or judgment against them, including attorney's fees and expenses incurred in defense of such claims, etc., made or brought by a myself, guest or crew member of my boat or their respective executors, administrators heirs, next of kin and assigns arising out of my boat's participation in the event or any related activities. I understand and hereby agree to abide by the Navigation Rules International/Inland including Rule 9 (b) which states: "A vessel of less than 20 meters in length or a sailing vessel shall not impede the passage of a vessel that can safely navigate only within a narrow channel or fairway."
